Treasurer's Report - Crystal Tressler

- 2019 ended with a 4% operating profit, \$2,075
- Year-end unrestricted checking account balance grew to \$39,033
- The 2020 forecasted revenue is \$56,390, a 15% increase over 2019
- The 2020 forecasted expenses total \$54,675, a 16% increase over 2019
- Net operating profit is forecast to be \$1,715 or 3%
- The presented budget includes 13 items for review/approval, net impact is -\$4,237

Discussion

- Discussed looking at ordering jackets for the Spires coaches, which are similar to the ones that the club is ordering, but with the Spires logo.
- Discussed RRCA coaching for the Spires coaches. Discussed USATF vs, RRCA coaching courses. The Spires are a member of USATF.
- Under General Operations, remove Google Adsense.
- Move CPR to training, and move AED and pop-up tent to equipment.
- Discussed a garment rack for the FRF Expo.

Spires Nationals 2020 Discussion

- Discussed not exceeding the budget for 2020 Nationals.
- Discussed how most clubs don't pay for kids to go to these events.
- Discussed Trevor James being unsure about going to Nationals again, due to the logistics.
- Discussed what happens if a family can't afford to go, as well as the time commitment for the 2 week post season training.
- Discussed getting group discounts for travel and hotel.
- Discussed reimbursing coaches and not families.
- Discussed how we don't pay for adult members to attend various events (i.e. Boston Marathon and Senior Olympics).
- Trevor James suggested that if people are interested and qualified, the parents pay for the children to get there, as well as the hotel, then the club could pay for two coaches to go.
- Discussed a placeholder for \$1,000. If it is more, coaches might have to pay.
